Course Description

In this course students will explore, in some depth, a controversy related to health care, health insurance, public health, or other aspects of health policy. Common readings will focus on controversies in the U.S. system, including <u>Remedy and Reaction: The Peculiar American</u> <u>Struggle over Health Care Reform, by Paul Starr</u>, and other shorter readings (all of which will be made available on the Canvas course site). <u>This course carries intensive writing credit</u>. Students will write up a paper on an approved topic, and will submit drafts of each section that paper in an orderly fashion. Most students are likely to write papers related to the U.S. case, but the instructor is open to topics that extend outside the limits of our country. Here is a sample of possible topics: any of the major components of Obamacare, Medicare, Medicaid, or other government programs, religious objections to contraception coverage, abortion, or vaccination, unequal access to health care or to health-related information, public support for medical research, high prescription drug prices, orphan drugs, drug abuse, legalization of marijuana use, antibiotic resistance, epidemics, malpractice insurance, patient dumping, disaster response, medical tourism, consolidation of care providers, a hospital's responsibility to its community (as in IU Health Bloomington's proposed relocation), and the public health consequences of sugary drinks, tobacco use, vapor cigarettes, genetically-modified foods, pollution, and the infrastructure of roads, sidewalks, and parks in a community.

Grading and Student Responsibilities

Semester grades will be based primarily on the quality of the seminar paper (85%) <u>and the student's participation in class discussions</u> <u>and other assignments (15%)</u>. Regular attendance will be taken, and students are expected to come to class each week. (For excused absences, you need to obtain permission from the instructor ahead of time, except in cases of emergency.) Points will be assigned for participation (based on attendance and the quality of comments made during class time) and for each of the intermediate steps of the paper construction process. These points will be assigned the following weights towards the final overall grade. *The seminar paper is the core of this course*. Students should plan on writing this paper in 5 parts (the first four of which will need to be revised along the way to make for a complete integrated whole by the end of the semester):

- 1. <u>Topic statement</u>: Initially need only a brief statement of your topic of interest, based on the nature of the problem or normative concern, as you understand it [Part 1 is 5% of course grade DUE JAN. 25]
- 2. <u>Literature Review and Problem Framing</u>: Expanded statement of topic, including a literature review of how this issue or problem has been defined and framed in the relevant policy discourse and/or research literature [Part 2: 15% DUE FEB. 15]
- 3. Configuration of relevant actors [Part 3: 15% DUE MARCH 7]
 - a. Which actors or stakeholders are especially concerned with this issue, and what their primary concerns are [Part 2]
 - b. The configuration of common and conflicting interests among these primary actors, and what sources of power and influence the relevant actors bring to the table, and the institutional forums in which those interactions play out
- 4. <u>Future prospects</u> [Part 4: Likely outcomes under status quo, and change being advocated, with justification): 15% DUE APRIL 11]
 - a. what you expect will occur if no major changes are made
 - b. What kinds of solutions seem desirable to you, and why, with a realistic evaluation of the prospects of such a solution being implemented and achieving its goal

5. <u>Final Paper</u>: Integrated seminar paper: 35% – DUE NOON, FRIDAY, MAY 6 – [Early submissions will be welcomed!] Additional details will be provided at appropriate times throughout the semester.

Schedule of Class Meetings and Assignments

Over the course of the semester we will move through five phases, starting with a primarily lecture format in initial weeks and quickly moving to sessions with an increasing proportion of seminar-style discussion-style presentations and discussions after that.

- 1. Quick overview of scope of potential topics for papers (week 1; week 2 NO CLASS for MLK Day)
- 2. Historical development of U.S. health system, with some global context (weeks 2-5)
 - a. Readings week 3, Jan. 25: : Starr, *Remedy and Reaction*, Introduction and chapters 1-7, pp. 1-238); submit draft topic
 - b. Readings week 4, Feb. 1: Starr, Remedy and Reaction, chapters 8-9, pp. 239-298, others TBA)
 - c. Readings week 5, Feb. 8, TBA
- 3. Conceptual tools from political economy and institutional analysis (weeks 6-9); Readings TBA
- 4. Discussion of paper topics under broad categories -- subject to rearrangement (weeks 10-14); Readings TBA
- 5. Wrap-up (week 15) No meeting Finals Week
